Collected data

This data will be stored and secured on EFKA's servers or on servers of a third party. We will not combine personal information with other information that we have collected.

Communication

We may retain messages or emails that you send to us. Sometimes we need personal details whom are relevant to some questions that are asked. Only then it is possible to process the question as requested. This data will be stored and secured on EFKA's servers or on servers of a third party. We will not combine personal information with other information that we have collected.

Cookies

We collect data for research and to gain better insight in our customers behaviour. So we could tailor our services accordingly. We use "cookies" to analyze our users behaviour on our website. We keep track on how you use the website, to compile reports based on website activity, so we could offer other services relating to the website activity and internet usage. The information that we generated via cookies are transferred to EFKA's servers or those of a third party.
